**Subject: 2016 Robert Madden Industries/ Xcel Residential Customer Incentive Program**

**Program Guidelines:**

- Equipment must be installed on property served by Xcel, as evidenced by a PERMANENT meter number.
- All required documents must be completed and returned before customer rebate checks are released.
- Systems must be installed by Air Conditioning Contractors who are currently licensed with the Texas Department of Licensing and Regulation and who carry the appropriate amount of insurance for the classification of the license held.
- All installations are subject to Xcel audit- Contractors are responsible for customer rebate funds, which do not pass Xcel audit inspections.
- This program has a limited budget. Robert Madden Industries reserves the right to terminate the program at any time, if all program funds are exhausted.
- All claims are due within 30 days of the installation date. Claims older than 30 days will not be honored.
- All systems must be **AHRI-matched** and meet the program's minimum energy efficiency requirements
- Any qualifying system must be submitted for claim by November 1, 2016
- New Construction and Retrofit Projects are allowed
- New Construction Project are allowed to roll to the following year, provide the Xcel program does not change from the current year.
- Single Family, Multi-family, and Mobile Home Projects are allowed, however multi-family project with more than 10 HVAC systems will not be allowed without the written permission of the Project Sponsor (Robert Madden Industries).
- Multi-family projects must be individually metered in order to qualify.
- Multiple systems at the same single family address are allowed.
- The residential project location DOES NOT have to be owner occupied.
